Request for Proposals for Public-Private Partnership Agreement for Rooftop Solar

Overview

The Rhode Island Convention Center Authority (the "Authority") requests proposals from qualified entities to develop and install a solar canopy system on the Authority's Clifford Street Parking Garage. Based on the responses to this Request for Proposals ("RFP"), the Authority will determine if the submissions meet the Authority's needs and objectives, as well as further the ambitious goal requiring 100% of Rhode Island's electricity to be offset by Renewable Energy by 2033.

The Authority is requesting respondents propose a turn-key operating solar canopy system to cover its Clifford Street Parking Garage located at 75 Clifford Street, Providence, Rhode Island that will deliver the maximum financial, economic, and environmental value to the Authority. The Authority is interested in exploring full ownership by the Authority or other alternative ownership structures that will maximize the values listed above.

Introduction

The Authority is a public corporation of the state of Rhode Island governed by an eleven-member board of commissioners. The Authority oversees the Rhode Island Convention & Entertainment Complex which includes the Rhode Island Convention Center and garages, the Amica Mutual Pavilion, the Veterans Memorial Auditorium, and the Clifford Street Parking Facility.

As the Authority's Consultant, Best Practice Energy will be compensated \$0.05/watt (DC) on the awarded developer's solar canopy system project. The awarded respondent will be responsible to reimburse the Authority for the RFP's Consultant's fees within sixty (60) days after the full execution of the Public-Private Partnership Agreement for the Clifford Street Parking Garage Rooftop Solar Canopy System.

All proposals received must be held valid for 180 days without exception.

 Each respondent must deliver four (4) paper copies of its proposal and one copy in its entirety on a thumb drive in an envelope or package marked "Solar Proposals" to:

- A one-page executive summary should accompany each proposal signed by individual with the Authority to bind the company.
- Submittals must be received at the above address by April 7, 2023 by 2:00pm, prevailing time, without exception. The Authority will acknowledge receipt of the proposals and announce who has submitted at that time. The Authority will not entertain submittals received after the opening time.

Inspection

The Clifford Street Garage is open to the public and its roof may be inspected by a proposer at any time.
